- You will not receive individual feedback on the results of these assessments.

Your participation will be CONFIDENTIAL, your assignment will be ANONYMIZED to protect confidentiality, securely stored and scored by faculty at TRU after the end of your course. Your anonymous scores will be included in the aggregated reports.

- The only people who will see your assignment with your name on it and know who consented will be the SAIL Project Team (Alana, Carolyn & Teresa) and we will not tell anyone.

- Your instructor will receive a summary report across student work, with no information about individual students' performance. The report will also be shared with some university committees to inform improvements to educational programming.
- Faculty who assess the volunteered assignments will not know the names of the students who created the assignment.
- The files will be securely stored for 5 years.

Participation is VOLUNTARY.

- We will only collect the course work from those who consent to participate.
- There are no consequences for declining to participate.

You can choose not to participate and even to withdraw.

- You may choose not to consent by closing this window. If you sign the Consent Form but change your mind about participating, **you may withdraw from the project prior to April 10, 2021** by emailing Alana Hoare. After April 11, 2021 assignments will be anonymized, and no copies of identifiable assignments will remain, so they can no longer be removed.
